All the items above are inclusive of surcharges required by law (Decree of 25.03.1986 OJ n. 172) for overtime and holidays.

It should be noted that are applied the Minimum Fees prepared by the National Association of Port Chemists in case of well-defined services provided such as the check prior to the activity COW and the discharge of dangerous goods included in IMSBC Code and how the verification of Gas Free for mooring.

For attendance, even complex, to verify Gas Free, use flame concerning different types of vessels in different areas and / or with further checks necessary could be applied tariffs on lumpsum basis.

For special or repeated attendance, or if are expected complex attendance, a dedicated lumpsum tariff could be applied.

If it will be necessary, in connection with needs and / or special conditions (attendance without notice with the character of "urgent business", etc..) the tariffs could be increased
