Letter Sea Service

Trieste, July 02nd 2015

Commencing from 01 August 2015 tariffs for garbage service within the port of Trieste are established as follows

A) Basic rates due for each service rendered to:

1 - Merchant ships berthed in the port of Trieste:

B) Basic rates to be paid per day or fraction for:

1 - Stay alongside vessel of floating crafts or containers suitable for the collection of garbage:

2 - Clearance of barges or containers upon completion of service:

3 – Disposal of normal solid waste exceeding 1 mc included in the service : Euro 40/mc

4 – Disposal of special waste : Euro 75/mc

5 – Supply of bags for different collection method

C) Surcharge and rebates:

The above flat tariffs eventually reduced in offer by tender, will be increased or reduced as follows:

- 1 - To services rendered to passenger ships at anchorage, that have no passengers aboard, rates shall be applied whereas at point 1 of paragraph A).
- 2 - For services to Italian men-of-war a 30 % rebate is applied,
- 3 - For services rendered, upon ship's request, during working days between 17.00 and 08.00, a 50 % surcharge is applied,
- 4 - For services rendered, upon ship's request, on holidays between 08.00 and 17.00 a 70 % surcharge is applied,
- 5 - For services rendered, upon ship's request, on holidays before 08.00 and after 17.00 and on Saturday after 17.00 a 100 % surcharge is applied,
- 6 - For services rendered to ships in dry-dock a 20 % surcharge is applied,
- 7 - For services rendered to ships on roads a 20 % surcharge is applied,
- 8 - If the garbage is collected by dustmen without the help of vessel's crewmembers a 25 % surcharge is applied.

Chapter II° Rules for the collection of waste produced by ships staying in Trieste port or roadstead.

Article 8: (use of ship's incinerator)

In the areas under the jurisdiction of the Marine Department of Trieste, ships are prohibited to use their incinerator intended to the elimination of produced waste.

We kindly ask you to inform your clients that for special waste withdrawal (mooring ropes, fireworks etc) is advisable to request the estimated expenses in advance to avoid unpleasant inconvenient.
